Wayne County is ranked 26th in the state with the highest unemployment rate, with Perry ranked at 32nd highest in the state. Lauderdale County is not in our service area, but their unemployment rate is 5.8% which makes it the highest in the state. Moore County is ranked 90th in the state, with only 5 other counties having a lower unemployment rate. Williamson County's unemployment rate is 2.5%, the lowest in the state.

The only county showing negative growth is Perry with Marshall and Maury counties showing the largest growth between 2016 and 2017.

Designated Qualified Opportunity Zones

The IRS designates "An Opportunity Zone as an economically-distressed community where new investments, under certain conditions, may be eligible for preferential tax treatment. Localities qualify as Opportunity Zones if they have been nominated for that designation by the state and that nomination has been certified by the Secretary of the U.S. Treasury via his delegation of authority to the Internal Revenue Service." Six our thirteen counties have been designated as opportunity zones. These counties are Bedford, Hickman, Lawrence, Lincoln, Marshall and Wayne. Being designated as Opportunity Zones will likely impact the community planning or at least open up planning discussions.

According to the Child Welfare League of America Tennessee's state poverty rate is 16.7% while 28% of the children under five are experiencing poverty. The Department of Children's Services 2016-17 report reflects that 236 children birth to age four were in State custody for the South Central Service area.

Children In Foster Care



According to the Department of Children's Services 2016-17 annual report there are 236 children under age four in our South Central Area. We have enrolled 12 foster children during the 2018-19 program year. During the 2017-18 program year, we enrolled 10 foster children. In 2016-17, our foster child enrollment was at five children. There is a positive trend, but the numbers should reflect a higher percentage of enrollees. Barriers the program is facing include communication with foster families about HS/EHS enrollment; being fully enrolled when a foster child applies means that child must be put on the waiting list and often foster families find alternative child care before a slot opens. Data is difficult to gather because of the sensitive nature of the situation, so the program depends on the Department of Children's Services for referrals.
