#### FROM THE EXECUTIVE DIRECTOR...



Another successful program year has passed for your constituents and our clients as we are

already making progress into the new program year. We are still adhering to the practice of "transparency accountability" to insure that we are doing business in a manner that will provide quality programs to those we serve. The past year was filled with monitors visits bv and auditors (unannounced in some cases) from the state comptroller's office, the state departmental offices, and the federal monitors or various programs to make sure we were complying with these The visits quidelines. were all productive and South Central had no findings the maior in any of which programmatic activities we oversee and/or the delivery of services to your constituents and our clients.

The new program year began with a certain amount of uncertainty and concern about the non-existent federal budget which proposed giant cuts in all of our programs and would have been devastating to those we serve. During the same time period a senior staff member of the State Department of Human Services changed program/fiscal calendar from that of the State to that of the federal government. This change extended last program year for three months and made the new vear a nine month year. It was soon discovered that this was done without input from the State or the federal government and we were changed back to the state calendar/fiscal year as in the past. Needless to say, that senior staff

person is no longer with DHS. It has caused some uncalled for problems such as allowing those who were not served in the last program year to be served during the three month extension and being told that they could reapply for the new year in October. Due to changing back we will not have to inform them that they cannot be served twice in the same year. This not only affected South Central but the other HRA's and Community Action Agencies across the state. The state is now in the process of creating a press release to try and explain this to the citizens of the state and make it as easy as possible for all of the agencies to explain what happened to their clients. We still have many clients facing the hard times due to the economy and natural disasters that happened again during the last year and the number per county still increases. One great event that took place was that Governor Haslam kept us in his budget and the state appropriation to all agencies was approved if they met their local appropriations amount.

It is imperative to us that you all strive to meet our local appropriations request in order for us to receive the state appropriations which go a long way in supporting the much needed programs and services that we provide.

I want to thank each and everyone of the employees again this year for the work they did during the last program year in doing their jobs and promoting their programs throughout the thirteen counties that make up South Central, our four counties located in the South East area where we provide the Title V program, and the two counties in the North West area where we provide the VITA program. Great job and thank you!

As reported during our quarterly Policy Council meetings we held a three day session to develop our three year strategic plan, we made improvements to our central office facilities with the installation of a security camera system, enclosing the entire back parking and delivery area with a security fence, and renovating a building in Wayne County (thanks to County Mayor Rich and his Court) to relocate County Neighborhood Service Center including a training/conference area for use by our western counties. All of these improvements were needed and we have already used the training/conference area on several occasions for several of our programs plus a local program that needed a place to meet. Over the coming years all of these improvements will be beneficial to the agency needs.

All of us working at South Central look forward to a new program year with

anticipation and pray that our funding will stay somewhere close to prior years less the ARRA monies. I can assure you that we will do the best job we know how to use the assets allowed us to deliver the programs and services to your constituents and our clients in order to "Help People Help Themselves!"

I appreciate you and your willingness to be a public official and a member of our Policy Council, Governing Board, and Executive Committee. I know from experience that many times it is a thankless job because people don't know and understand what all you have to do to serve in the position to which you are elected. I also appreciate the Consumer Representatives from each county, the Minority Representatives, and the Consultants that serve on the Policy Council with you. Thank you for giving of your time and talents to assist us in our mission. If any of us can ever be of assistance to you, do not hesitate to call and we will do our best to meet vour needs. As always, it is my pleasure to work for and with you to make our agency what it is today!

#### SOUTH CENTRAL HUMAN RESOURCE AGENCY

#### **PROFILE**

The South Central Human Resource Agency (SCHRA) was created July 11, 1973; and chartered as a public non-profit agency February 19, 1975. Its goal is to promote the development of human resources in South Central Tennessee through effective and efficient delivery of human services.

In the years that followed, the SCHRA expanded its programs and emerged as a recognized leader in helping economically disadvantaged, elderly and handicapped persons in the South Central Development District.

From our Central Office at 1437 Winchester Hwy. Favetteville. in Tennessee. we strive to effectively deliver human service programs and oversee the coordination efforts through our 14 Neighborhood Service Centers located in each county seat. following 13 counties served by the SCHRA contain over 6,500 square miles of vastly rural country and supports a

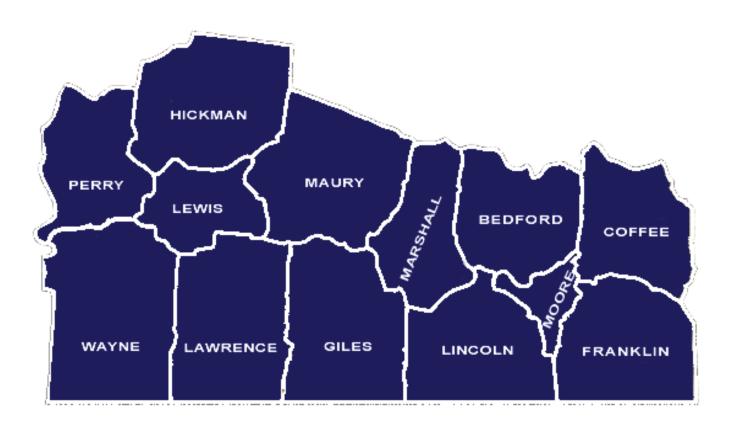
population of approximately 423,343 individuals: Bedford, Coffee, Franklin, Giles, Hickman, Lawrence, Lewis, Lincoln, Marshall, Maury, Moore, Perry, and Wayne.

Across this region in fiscal year 2011, SCHRA had in place 22 Neighborhood Service Centers. Head Start Centers, 23 Pre-K classroom collaborations, 3 Early Head Start Centers, 21 congregate meal sites and 2 main kitchens. During this year, the SCHRA channeled over 23 million dollars through grant/contract programs and employed approximately people.

Guided by our Governing Board and Policy Council, the South Central Human Resource Agency lives its motto daily:

"HELPING PEOPLE HELP THEMSELVES"

#### **SCHRA Service Area**



SCHRA has a Neighborhood Service Center (NSC) in each of our 13 counties (two in Coffee County) to provide access to programs and referral to other services in the community. We have 22 Head Start Centers across our area, 3 Early Head Start Centers located in Bedford, Giles, and Lawrence counties. 23 Pre-K Classroom collaborations in the following counties. The Nutrition Program has 21 congregate meal sites and 2 main kitchens – one in Fayetteville, Lincoln County, and one in Hohenwald, Lewis County.

Foster Grandparents- FGP	Provides stipend volunteer opportunities for limited income persons age 55 and over to give support services to children with "special needs" in the community
Retired Senior Volunteer Program	Provides opportunities for retired persons age 55 and older to serve their communities through volunteerism.
Senior Community Service Employment Program - Title V	Assists economically disadvantaged people age 55 and older by providing immediate supplemental income, work experience, training and assistance with placement in permanent employment situations.
Low Income Energy Assistance Program - LIHEAP	Provides financial assistance for heating costs to elderly, handicapped and low income persons.

Alcohol/Drug Safety Education	A court ordered education program providing a minimum of 12 hours of education pertaining to substance abuse, physiological and psychological aspects of alcohol and drug use.
Head Start/Early Head Start	Provide comprehensive educational opportunities for low-income and special needs children and empower families.
Food Service Program	Provides a hot nutritious noon-time meal to individuals for a fee without limited qualifications.
Nutrition Services for the elderly	Provides a hot nutritious noon-time meal at congregate meal sites for individuals 60 years of age and older, and delivers meals to eligible homebound.
Ensure	For sale to the public, with no qualifications, at a discounted price.
Catering	The Nutrition Program offers full service catering to the public for a fee, depending on what you order. The funds from catering help generate enough income to purchase equipment as needed and to help sustain the Nutrition program at five days a week.
Community Representative Payee Program	Provides money management services to assist persons who are incapable of keeping track of financial matters. Must receive Social Security or disability benefit and certified by a physician to be incapable of money management.
Private Pay Homemaker Services	Provides light housekeeping and respite sitter services, on a fee basis, with no limiting qualifications.
Volunteer Income Tax Program (VITA)	Volunteers complete annual tax returns for low and moderate income taxpayers free of charge.
Fingerprinting Service	Provides fingerprinting services to the public.

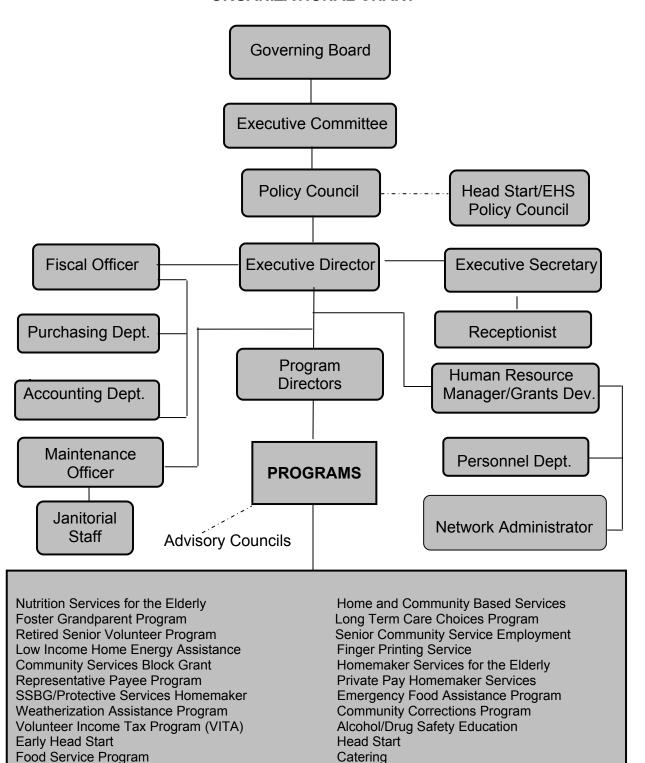

#### OVERVIEW OF SCHRA REGULATORY BODIES THE GOVERNING BOARD, EXECUTIVE COMMITTEE & POLICY COUNCIL

The corporate powers of the South Central Human Resource Agency (SCHRA) are vested in its Governing Board, which is responsible for fulfilling Agency objectives and establishing policy guidelines and direction. The SCHRA Governing Board has delegated authority to the Executive Committee of the South Central Tennessee Development District (SCTDD) to act for it, and has authorized the Policy Council to administer Agency activities within the framework of established policies and in conformance with Federal/State program guidelines.

The SCHRA Governing Board is composed of representatives from each of the 13 counties that the Agency serves. Membership consists of the county executive/mayor of each county, the mayor of each municipality, thirteen human resource representatives appointed by the county mayor/executive, and one state senator and one state representative whose districts lie within the Development District.

Similarly, the Executive Committee of the SCTDD is comprised of 13 county/metro executives, three minority representatives, one state senator, one state representative, and seven city mayors; and, as authorized, acts for the Governing Board.

The membership of the Policy Council is comprised of one third elected public officials currently holding office, one third are persons chosen in accordance with democratic selection procedures to assure that they are representatives of the poor in the area they serve, and the remainder members are officials or members of business, industry, religious, welfare, education, and other major groups with interest in the community. This is known as a tri-parte board to insure compliance with the Community Services Block Grant Act.

Additionally, serving on the Policy Council in a non-voting status, is a Head Start Policy Council Representative, Licensed Attorney, Financial Management Representative, and an Early Childhood Education Representative. These seats on our board are to meet the requirements of the Head Start Act.

The Policy Council meets four times a year; the Executive Committee of the SCTDD, acting for the SCHRA Governing Board, meets in concert with and ratifies Policy Council Actions including program budgets, proposals, and contracts approved by the Policy Council. The SCHRA Governing Board meets annually.

The members of these bodies play a critical role in overseeing programs, ratifying policies and helping to plan the future of our Agency. Without a strategy based on knowledge and placed in the hands of competent and concerned individuals, we would have only random ideas without a guiding purpose or direction.

VITA is an IRS grant that is designed to help low and moderate income taxpayers have their annual tax return completed by IRS certified volunteers.

SCHRA joined a coalition with United Way of Metropolitan Nashville in 2008 to administer the VITA (Volunteer Income Tax Assistance) Program across the 13 counties that SCHRA serves and have continued this partnership. In addition to our 13 counties, in program year FY'11, we also served Benton and Waverly counties at their request.



In program year FY'11, VITA volunteers prepared 1,898. Based on \$150.00 per return, we saved the tax payers in our communities \$300,000. The total amount of tax returns was \$2,829,000. We have applied for the grant again for the upcoming year and hopefully we will be able to continue providing this much needed service. We could not have accomplished this project if it had not been for the 30 dedicated volunteers that assisted us with the preparation of the returns.

AARP AWARD RECIPIENT: Ms. Mary Ann Meyer-Shuck of Fayetteville is the 2011 recipient of the AARP Tennessee Andrus Award for Community Service. She was the unanimous choice of the AARP Tennessee Executive Council for AARP's most prestigious honor, given to outstanding older Tennesseans who are making a powerful difference in their communities. Mary Ann has been an avid RSVP volunteer for a number of organizations in our community but one in particular is the VITA Program. **SERVICES PROVIDED:** The South Central Human Resource Agency SSA/Title V Program serves a twelve (12) county area with an allocated slot level of 114 clients for program year 2010-11 with slots assigned based on Census figures within our service area. We are also serving four (4) additional counties outside of the SCHRA area: Bledsoe, Grundy, Marion, and Sequatchie. Title V clients who cannot immediately be placed into an unsubsidized job receive assistance on finding a job and/or are assigned to eligible non-profit and government agencies for approximately 20 hours of work per week. In these assignments, clients receive valuable work experience and skill training while assisting their host agency in delivering essential community services. They also receive supportive services and training designed to prepare them for unsubsidized employment in the private sector.

the prospect of needing to compete for a job just to make ends meet. They are part of a generation that is too proud to accept public assistance and that understands what it means to work hard and do your best. While all need financial assistance, many clients also long for the social interaction - - the chance to continue learning and possibly start a new career and the opportunity to make a real difference in their communities.

**SPECIAL ACCOMPLISHMENT/CHALLENGES:** With the continuation of CAA funding, we were able to add computers and other office supplies to all our Title V offices. This assisted with training for participants and job developers. We also were able to work with an additional 38 plus folks.

**SPECIAL ACCOMPLISHMENTS:** The Head Start Program continued its collaboration with the Franklin County Schools Pre-K for the fifth year. Additional collaborations include Maury County and Wayne County schools. Head Start served a total of 1,155 three and four year olds during the program year and 93 children birth to three and pregnant women. Head Start FY'11 served 128 children with special needs. Of the 1,080 families served, 694 received at least one social service. All the children served were up-to-date on all immunizations appropriate for their age and 99% had a medical home established when they left the program.

#### WILLIAM MARK WHITAKER

#### FOURTH INDUCTEE - POSTHUMOUS FEBRUARY 17, 2011



Born November 13, 1920 and a native of Marshall County, TN. He was the son of the late Holland Benjamen and Mary Gillespie Whitaker. He was retired from the Department of Office of Economic Opportunity (Elk & Duck Rivers Community Association), a veteran of the Army Air Corps, serving in World War II, and was a member and Elder of the First Presbyterian Church in Petersburg, TN. He was also a member of the American Legion, the Sons of the American Revolution and former member and president of the Petersburg Lions Club. He had a great

photographic mind and would express his opinion to anyone that would listen. He loved politics and helping the underprivileged. Mr. Whitaker was instrumental in the creation of Elk & Duck Rivers Community Association and fighting the "War on Poverty".

Mr. Whitaker served as the first Executive Director of the Elk & Duck Rivers Community Association from 1965 – 1975.

Mr. Whitaker passed away on February 4, 2011. Survivors include his wife, Charlotte of Petersburg; son Bill Whitaker and wife of Pensacola, FL; and a daughter, Bette Harris and husband of Lafayette, LA.

#### JAMES ROY TIPPS

#### FIFTH INDUCTEE FEBRUARY 17, 2011



Born in Cook County, Illinois on August 27, 1928. His family moved to Winchester, TN in December 1928. His parents began dairy farming where Mr. Tipps worked in the family business until he was eighteen and joined the Air Force in 1946. He served as a radio operator in the Pacific Theater for 18 months. He married Edna Crabtree on April 3, 1950. After completion of his military service and subsequent marriage, he trained as an electrician and cabinet maker, but god had other plans for him. He was employed as an officer manager and chief time keeper for the construction of the Arnold Engineering Development Center military complex in

Tullahoma, TN. In 1958, Mr. Tipps entered the political world and was elected Register of Deeds for Franklin County, serving three 4 year terms. He was then elected County Judge of Franklin County for an 8 year term and part of his responsibilities included Chairman of the South Central Development District and the South Central Human Resource Agency. He was then employed by South Central Human Resource Agency in October 1982 as Executive director. The challenge he faced as Executive Director was to merge Elk & Duck Rivers Community Association into the South Central Human Resource Agency. Upon his retirement from SCHRA in 2006, Mr. Tipps stated that, "He always felt like SCHRA was his work family, his calling and was thankful for the high honor and privilege of every relationship he enjoyed!"

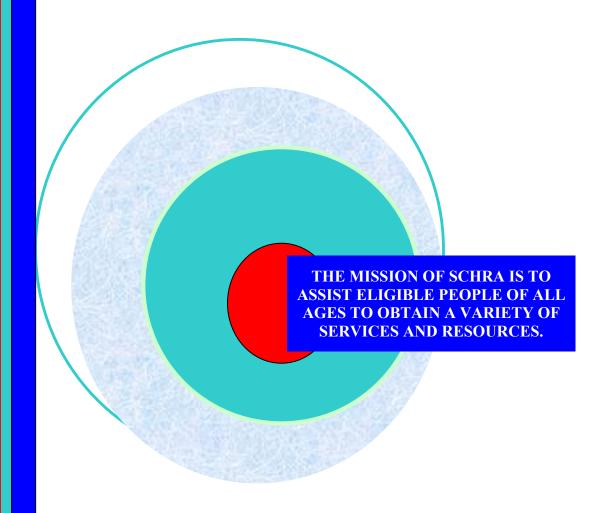
